





"99.9 THE HAWK-WODE, MILLER KEYSTONE BLOOD CENTERS, AND CIOCCA SUBURAU VEHICLE LEASE GIVEAWAY OFFICIAL CONTEST RULES

Section 1 Duration of Contest

1.1 Duration. Connoisseur Media, operating 99.9 The Hawk WODE-FM (the "Station"). Miller Keystone Blood Centers ("Miller"), Ciocca Subaru ("Ciocca Subaru") (collectively, the "Contest Organizers") are running a contest from Monday, December 10, 2018 to Saturday, January 26, 2019, excluding holidays or until terminated sooner by announcements on Station.

Section 2 How to Enter & Win

- 2.1 Enter in person at Ciocca Subaru at 4611 Hamilton Blvd, Allentown, PA 18103 or any Miller Keystone Blood Centers at 1465 Valley Center Parkway, Bethlehem, PA 18017-: 1255 S. Cedar Crest Boulevard, Suite 1300, Allentown, PA 18103-: and 2925 William Penn Highway, Suite 105, Easton, PA 18045 between Monday, December 10, 2018 to Saturday, January 19, 2019 to qualify to win a 2-year lease on a 2019 Subaru Impreza 2.0i. Entrants are limited to individuals: no businesses are eligible to enter.
- 2.2 There will be 10 people that will be randomly selected to participate in the Grand Finale at Ciocca Subaru on Saturday, January 26 from 11a.m. to 1p.m. (the Finalists").

Section 3 Qualifying General Rules

- 3.1 Must be 21 or older to participate.
- 3.2 No purchase necessary to enter.
- 3.3 Odds of becoming a finalist depends on number of entries.
- 3.4 You may only win once during the contest.
- 3.5 People selected as Finalists will be notified by phone and email the week of January 21, 2019, and must affirmatively respond to this notification within 24 hours. Failure to do so will result in their disqualification and another person will be randomly selected for that spot. Finalists must be present at Ciocca Subaru for the Grand Finale on Saturday, January 26, 2019 in order to be eligible to win the 2019 Subaru Impreza 2.0i 2-year lease. Check-in time will be from 10:30-11am. No proxies will be permitted. If Finalists are not checked in with Contest Organizers by 11am, they will be disqualified. No exceptions.
- 3.6 Only one winner per prize. No "duos," groups, or teams will be allowed to enter together. Any ties, disputes, conflicts, questions, or concerns regarding the Contest and/or the prize(s), will be handled by the Contest Organizers, whose decision(s) are final and binding. Contest Organizers are not responsible for mechanical, technical, electronic, communications, telephone, computer, hardware or software malfunctions or failures of any kind, including: failed, incomplete, garbled or delayed transmission of entries, traffic congestion on telephone lines, the Internet or website unavailable network connections which may limit a person selected as a Finalists from replying to the notification







described in 3.5 above, any injury or damage to entrant's or any other person's computer related to or resulting from participating in or downloading any information necessary to participate in this contest. Contest Organizers are not responsible for ineligible entries or entries with incorrect information. Contest Organizers disclaim all liability for any delays or traffic issues experienced by people in transit to enter or Finalists in transit to the Grand Finale.

Section 4 Prize

- 4.1 Prize is a 2-year lease on the 2019 Subaru Impreza 2.0i that includes 24 months, 10,000 miles per year. Vehicle includes air conditioning, power locks and windows, ABS brakes & remote keyless entry. All factory rebates and incentives will be signed over to Ciocca Subaru. If winner exceeds mileage limit, winner will be responsible to pay \$.15 for each mile in excess of 10,000 miles per year. At the end of the 2-year lease, the vehicle must be returned to Ciocca Subaru. Winner must abide by the financial institution terms and conditions governing the lease. Winner is subject to approval by Subaru Financial. Grand prize winner must provide Ciocca Subaru with valid driver's license, acceptable auto insurance, valid identification and a valid taxpayer identification number or social security number before any prize will be awarded. Failure to timely provide such information and/or any other reasonably required documentation, including, without limitation, a release and affidavit of eligibility in a timely manner may result in not receiving prizes or the forfeiture thereof. Winner is responsible for all fees and taxes associated with receipt of prize. In the event the winner chosen is not able to meet the requirements set forth in these rules, Ciocca Subaru will allow the prize to be transferred to an immediate family member of winner who is able to meet the requirements set forth in these rules.
- 4.2 Value of 2-year lease is \$6,859.72. List price of vehicle is \$20,233.
- 4.3 Prize may not be redeemed for cash.
- 4.4 Winner must sign a w9 form prior to taking receipt of prize.
- 4.5 Contest Organizers are not responsible if the prize awarded becomes unavailable due to any reason beyond Contest Organizers' control.

Section 5 Grand Finale

- 5.1 All Finalists must be present at the Grand Finale at Ciocca Subaru at 4611 Hamilton Blvd, Allentown, PA 18103 on Saturday, January 26, 2019 and checked in with Contest Organizers by 11am to be eligible to win.
- 5.2 Check-in time will take place between 10:30 and 11am on Saturday, January 26, 2019.
- 5.3 All Finalists must show proper photo identification at check-in.
- 5.4 No proxies are permitted. If Finalists are unable to attend or are not checked in by 11a.m., they will be disqualified.
- 5.5 Each Finalist will select a fob to use to try and start the car. The person with the fob that starts the car, subject to meeting all other requirements in these rules, wins the 2-year lease of the Ciocca Subaru 2019 Impreza 2.0i.







Section 6 Acceptance and Delivery of Prize

- 6.1 Contest Organizers retain the right to substitute prize(s) with other prize(s) of equal or greater value in the event the original prize(s) offered is not available for reasons beyond their reasonable control.
